The mayor and city council agreed. There was also discussion on raising the turn on and turn off fees to \$100.00 each instead of the \$35.00 that is currently in the ordinance. The current deposit for renters is \$200.00, that will be raised to \$250.00. The city clerk will contact the city attorney to update the Ordinance 92.05.
